

REQUIREMENT OF LAND: TELANGANA STATE TERMS AND CONDITIONS

- 1. The land offered on National Highway shall meet the NHAI guidelines contained in Govt. of India, Ministry of Road Transport & Highways letter no.RW/NH-33023/19/99-DO-III dated 25.9.2003, 17.10.2003, 24.7.2013 and letter no. RW/NH-33032/01/2017-S&R (R) dated 26.6.2020 and further amendments, if any.**
- 2. The land offered on State Highways shall meet the applicable IRC norms.**
- 3. The property should have a clear and marketable title.**
- 4. The bidders shall arrange for all statutory clearances such as Urban Land Ceiling, Non-Agricultural Permission, Income-tax clearance, Nil-Encumbrance Certificates etc.**
- 5. Plots of land with availability of electricity and water connection will be preferred.**
